ADDITION TO THE ALRC SUPPLEMENTARY COMPETITION REGULATIONS

At the ALRC S&ORC meeting held on the 16th November 2019 the following Competition Regulation changes were recommended to go forward to the ALRC Council for their ratification on safety grounds to take immediate effect with others mentioned in the S&ORC meeting minutes will be discussed at the ALRC Council meeting on the 8th February 2020.

a. Section G – Competitive Safari – Specific Technical Regulations

G.4 Brake lights

G.4.1. Brake lights are mandatory and they must be rearward facing and mounted as high as is practicable within the bodywork confines.

Implemented 16th November 2019

b. Section H – Timed Trial – Specific Technical Regulations

H.2. Seats & Seat Belts

H.2.1 A minimum of a 4 point safety belt with two shoulder straps and one abdominal strap to be worn by all occupants whilst on section.

Implemented 16th November 2019
